The VWR Collection Disposable Spatula is a polypropylene (PP) tool for spooning, scooping, scraping and stirring of a variety of samples or chemicals. This tool is for **Research use only** and is not a medical device.

The VWR Collection Disposable Spatula meets food contact standards. The materials, manufacturing process, standards and procedures used to manufacture the product, meet FDA standards for plastics coming into contact with food as defined by the FDA in 21CFR Part 177 subpart B: Substances for Use as Basic Components of Single and Repeated Use Food Contact Surfaces, part 177.1520.

Quality Control: Random samples of each batch are reviewed for adherence to size, weight and other manufacturing specifications.

Standard & Macro: Made of 100% Virgin Food Grade PP (80081-188, 80081-190, 80081-192, 89097-816 & 10816-246)

Eco: Contain 99% Virgin Food Grade PP, 1%, by weight, EcoPure® Additive * (89233-128)

Micro: Contain 96% Virgin Food Grade PP, and 4%, by volume, AMPACET 40390 Hostat 10 BOPP Masterbatch, an internal antistatic agent. (80081-194)

Sterile: Standard Opaque spatulas, which meet food contact standards, are sent to a 3rd party processor in the USA for repackaging and sterilization. The products are sterilized to an SAL of 10⁻⁶ using ethylene oxide as the sterilant in compliance with ISO 11135 requirements. (89097-816)

Sterile Non-Toxic, Non-Pyrogenic: This product is further processed and tested to meet Endotoxin Limits per USP 85 requirements (≤ 0.5 EU/ml or 20 EU/device). (10816-246)

BSE/TSE: No raw materials that contain, or are derived from, animals are specified in the manufacture of Standard, Standard Sterile, Macro and Eco versions. (80081-188, 80081-190, 80081-192, 89233-128, 89097-816 & 10816-246)

BSE/TSE Micro: Micro spatulas contain 4%, by volume, AMPACET 40390 Hostat 10 BOPP Masterbatch, an internal antistatic agent. (80081-194)

The following statements in italicized text have been excerpted in their entirety from the Ampacet Regulatory Status document for 40390 Hostat 10 BOPP Masterbatch and relate only to the Ampacet additive that is used to give the micro anti static product the desired level of surface resistivity.

Food Contact Status: "This material is composed of ingredients that are cleared by the U.S. Federal Food and Drug Administration (FDA) for use in Polypropylene as described in sections 174.5, 177.1520 (c) 1.1a, 178.2010, 184.1505, and 178.3297 and may be used in food contact applications subject to applicable restrictions described herein and in Title 21 of the Code of Federal Regulations."

BSE/TSE: "This product contains one or more ingredients formulated with animal-derived substances that comply with USDA/APHIS Title 9 CFR, EMEA/410/01 (rev. 10/02/02), EU regulation 1774/2002/EC, Directive 2000/6/EC and Commission Directive 2003/32/EC."

Expiration: **Non-sterile Product:** If stored in a cool, dry location polypropylene resins should have an unlimited shelf life. Heat and direct sunlight will degrade most plastic polymers. Storage of the above referenced products out of direct sunlight and under normal lab conditions should result in an unlimited shelf life.

Sterile Product: Sterile Barrier testing was performed per ISO 11607-1 requirements along with Distribution Simulation testing. The repackaged sterilized spatulas will remain sterile as long as the inner pouch containing the 10 sterile spatulas remains visually intact. The seals on this product are certified to remain intact for a minimum of 72 months.

Lot specific Certificates of Conformity and/or Certificates of Sterility are available upon request.

***EcoPure® Additive:** Eco Disposable Spatulas are produced with the EcoPure® Additive, which helps promote biodegradation in the polypropylene resin. "EcoPure® requires the action of certain enzymes for the biodegradation process to begin, so plastics containing EcoPure® will never begin to biodegrade during normal use." [2011, Bio-Tec Environmental, USA] The Spatulas produced using this additive were subjected to third party testing and found to biodegrade an average of 28.4% in the first 586 days of testing under conditions that simulate a biologically active landfill using the ASTM D5511 test protocols. Present tests, at 49% solids content, approach the conditions of wetter landfills, such as those in the southern United States. Biodegradation rates may be lower in landfills in other areas of the U.S. depending on the moisture level in those landfills. ASTM D5511-11: This test method also may resemble some conditions in biologically active landfills where the gas generated is recovered and biogas production is actively promoted.

Important California Notice
