Additional regulatory information

We hereby confirm that the above-mentioned product complies with the requirements of Article 5 of EU Regulation 2025/40 (Packaging and Packaging Waste Regulation – PPWR). The total concentration of heavy metals lead (Pb), cadmium (Cd), mercury (Hg), and hexavalent chromium (Cr VI) does not exceed the limit of 100 mg/kg. The product does not contain, neither as a whole nor in any component parts, per- and/or polyfluoroalkyl substances (PFAS). PFAS are not intentionally used in the manufacturing of this product. The assessment of the absence of PFAS is based on control of the material composition and on information provided to us by our suppliers.
