#### 4. First aid measures

Protection of first-aiders

: No action shall be taken involving any personal risk or without suitable training. ### 5. Fire-fighting measures

# 7. Handling and storage

Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed.
