SECTION 4: First aid measures

4.1 General information

First aider: Pay attention to self-protection! IF exposed: Immediately call a POISON CENTER/doctor. Symptoms may develop several hours following exposure; medical observation therefore necessary for at least 48 hours.

In case of inhalation

Immediately call a POISON CENTER/doctor. Remove casualty to fresh air and keep warm and at rest. If breathing is irregular or stopped, administer artificial respiration. No mouth-to-mouth or mouth-to-nose resuscitation. Use Ambu bag or ventilator.



In case of skin contact

Immediate medical treatment required because corrosive injuries that are not treated are hard to cure. Rinse skin with water/shower. Take off immediately all contaminated clothing. Subsequently wash off with: Calcium gluconate solution Symptoms may develop several hours following exposure; medical observation therefore necessary for at least 48 hours.

After eye contact

In case of contact with eyes flush immediately with plenty of flowing water for 10 to 15 minutes holding eyelids apart and consult an ophthalmologist. Protect uninjured eye. Remove contact lenses, if present and easy to do. Continue rinsing.

In case of ingestion

Immediately call a POISON CENTER/doctor. Rinse mouth thoroughly with water. Subsequently wash off with: Calcium gluconate solution Milk Put victim at rest, cover with a blanket and keep warm.
