## 5. Fire-fighting measures

Flammability of the product : Fine dust clouds may form explosive mixtures with air.

Extinguishing media

Suitable : Use dry chemical powder. Not suitable : Do not use water iet.

Special exposure hazards

: Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. #### 6. Accidental release measures

# 7. Handling and storage

Handling

: Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. ### 7. Handling and storage

Storage

Eliminate all ignition sources. Separate from oxidizing materials. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Use appropriate containment to avoid environmental contamination.
