4 . First aid measures

6 . Accidental release measures

8 . Exposure controls/personal protection

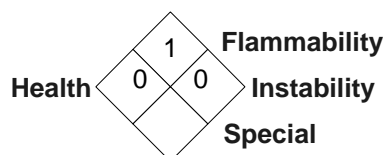
