Section 2 : **Product Composition (Classification)**

The subject formulation is a nutrient blend of inorganic salts, organic compounds, amino acids, vitamins and carbohydrates. Phenol red is included as a pH indicator. After preparation in purified water, all ingredients are in concentrations of less than 1%.

Section 3 : **Hazards Identification**

Section 4 : **First - Aid Measures**
