4. First aid measures

Protection of first-aiders

: No action shall be taken involving any personal risk or without suitable training. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. 5. Fire-fighting measures

6. Accidental release measures

Personal precautions

7. Handling and storage

Handling
