Extinguishing Media: Dry chemical, foam, or carbon dioxide. Water is acceptable to use on these solutions due to the weak concentrations of acid involved.

Fire & Explosion Hazards: Contact with most metals causes formation of flammable and explosive hydrogen gas. However, the risk is reduced due to the weaker

concentration of Sulfuric Acid present.

Fire Fighting Instructions: Use normal procedures/instructions.

Fire Fighting Equipment: Use protective clothing and NIOSH-approved breathing equipment appropriate for the surrounding fire.

#### Section 6: Accidental Release Measures

Cover the spill with Sodium Carbonate or a soda ash-slaked lime mixture (50:50). Mix and add water to form slurry. Decant the liquid to the drain with excess water. Treat the solid residue as normal refuse. Wash site with soda ash solution. Always dispose of in accordance with local regulations.

As with all chemicals, wash hands thoroughly after handling. Avoid contact with eyes and skin. Protect from freezing and physical damage. Do not mix with bases.
