4. First aid measures

5. Fire-fighting measures

Flammability of the product : No specific fire or explosion hazard.

6. Accidental release measures

8. Exposure controls/personal protection

Engineering measures : No special ventilation requirements. Good general ventilation should be sufficient to control worker exposure to airborne contaminants.
